## Valuing Individual Differences

People are different in many ways. Tolerance, acceptance, and respect for differences require experience. To raise children to be sensitive to the differing characteristics, abilities, and lifestyles of others, there are three key things to do.

### ✓ **Model Tolerance**

We teach children by example. Children watch what we do. What messages of acceptance and tolerance are you modeling for your child?

### ✓ **Expose children to differences**

Far more often, people respond to difference with fear. The unknown is frightening. Experience replaces fear. Children can easily learn to see people for who they are rather than how they look. It takes experience to reduce the aversion fear invites.

### ✓ **Ask Questions**

Challenge your child to think through his discomfort. "How does having a different nose make a child less fun?" Children need opportunities to express their ideas, gain new information, and to examine their thoughts. That is the process of thinking.

Be sure to include an opportunity for your child to make amends if someone else feels slighted, hurt, or insulted. Ask your child what he might do to help the other person feel better. A child might choose to apologize, draw a picture for the other person, or show kindness in another way. This process shows respect for the dignity, worth, and pride of each individual.
